### Review of the year

At the end of last year's report I wrote that I hoped that in 2021 we would continue to reach out and bless our congregation, community and the wider world. Looking back over the past twelve months I can see that we have, despite many challenges, been the blessing we hoped to be.

The year started rather depressingly with another lockdown. But by now we were amateur experts in all things digital and we again moved online broadcasting our services on facebook and youtube. Reverend Nicki Pennington and I shared "Baking through Lent" videos and ideas and reflections for families called "A Crafty Lent". Our Good Friday "Hour at the Cross" service was in the form of a video including musical contributions on the Father Willis organ from Frank Bowler.

It was wonderful to be back together for in person worship again at Easter, and a joy to hold weddings and baptisms in the Priory again, despite the restrictions, and to meet for our APCM and worship in May. At this service we thanked outgoing warden Derek McGee and welcomed a new warden to the team, Tom Kelly. Several PCC members did not stand for re-election and we were sad to see them go but grateful for their contribution. We were also sad to say goodbye and thank you to an excellent Parish Secretary, Vicky Bearman. A faithful supporter of the Priory for many years, Mary Branford, retired from leading the flower arranging rota this year. We are pleased that several parishioners are continuing her good work, albeit on a smaller scale.

In the summer, inspired by Carlisle Diocese's refreshed "God for All" vision we began to embed the four themes of "Tread Gently", "Care Deeply", "Follow Daily" and "Speak Boldly" into our worship.

This would not have been possible without the participation and support of the retired ministry team and our Rural Dean.

### Tread Gently

This year's COP 26 conference in Glasgow in September was a defining moment in our efforts to combat climate change. In 2021 we responded to our need to reduce our carbon footprint by exploring becoming an Eco Church. We set up a working party to look at what needs to be done to achieve a bronze award. From September to December our worship was focused on the theme of "tread gently".

### Care Deeply

In December we began to explore what it means to "care deeply" for one another and our worship explored this theme. The PCC heard a presentation on the work of the "Welcome Churches Network" and we signed up to be a church that welcomes Afghan refugees. In November we hosted a service for groups supporting 16 Days of Activism Against Gender-Based Violence.

At the end of the year we hosted our first ever Christmas tree festival and it was a resounding success. We were so pleased to welcome charities, voluntary groups, schools and businesses into the Priory and to enjoy their innovative and even profound Christmas tree creations.

2021 was a busy year for our ministers, wardens, PCC, cleaner and caretaker as together we tried to find our way through the Covid 19 crisis; enabling people to worship whilst keeping them safe. We look forward to 2022 with hope as we begin to explore further the themes of "follow daily" and "speak boldly" continuing to look for ways to be a blessing whatever may befall.

### Structure, governance and management

The Parochial Church Council is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure (1956) as amended and Church Representation Rules.

The PCC became an Official Charity registered with the Charity Commission on 1 August 2011, Charity Number 1143193.

### Recruitment and appointment of members

Members of the PCC are either ex officio or elected by the Annual Parochial Church Meeting in accordance with the Church Representation Rules.

The Priory is led by a ministry team and the church council, who are responsible to the Bishop of Carlisle. The ministry team is as noted on page 3.

The Priory has a rich musical heritage, which is led today by our organist/ choirmaster. He leads the choir and plays our famous organ as well as the grand piano as appropriate for the occasion.

For a hundred and fifty years, bell-ringers have summoned people to worship. It's not just a time prompt, but a spiritual reminder in a world of secular values that a religious service is about to take place in the midst of the community. The ringers are led by the Tower Captain.

### Key management personnel

The members of the PCC consider that they themselves comprise the key management personnel of the charity, in charge of directing and controlling the charity and running the operation of the charity on a day to day basis. Subject to remuneration paid for specific roles as shown in note 6 to the accounts, all members give of their time freely. Details of members' expenses and related party transactions are given in note 6 to the accounts.

### Related parties

The Friends of the Priory support the Priory through social and cultural events and encourage interest in its history, architecture and heritage. There are other dedicated groups of volunteers who are generous with

their time in organising the cleaning and gardening at the Priory, and in arranging social events.

### Objectives and activities

The PCC's objectivess are promoting in the ecclesiastical parish the whole mission of the church. Our vision is to know Jesus Christ better and make Him better known.

### Public benefit

The members have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in planning future activities, and how these planned activities will contribute to the aims and objectives they have set.

### **Achievements and performance**

The Priory was closed for public worship from January until Easter, with services being livestreamed. Holy week services were held on Zoom (as was Evening Prayer from February); the Mothering Sunday service was online, but daffodils were delivered to the door of senior worshippers. On Easter Day services resumed in church, with Livestream being continued throughout the year. Evening Prayer restarted in April; Ascension Day service was held outdoors in the church grounds; 2 morning services resumed in September with an alternate pattern of services. An All-Age service was zoomed monthly on Sunday afternoons. Sunday refreshments and Pop-In Centre restarted in September. A Story Service started in September at 9.00 am – held monthly.

Festivals were held as usual but with restrictions of distancing, mask-wearing and sanitising:-

Harvest festival held in October; all Christmas services were held; and the new Christmas Tree Festival throughout December attracting over 300 visitors. Christmas services were well-attended – the Carol service; Christingle; the Crib service; and the Communion services.

### **Report from PCC Secretary**

Since the last APCM in May 2021, the PCC have met largely in person within the Priory and more recently in New College Hall due to the relaxation of Covid restrictions. With this relaxation, the discussions on Covid restrictions, alongside the other matters arising for the PCC for the Priory, have been regular and in depth to ensure balance between safety for the congregation from the risk of Covid and allowing a more 'normal' life to resume. Aside from Covid, many aspects for the church have been discussed, notably from October 2021 a change to the structure of PCC meetings saw time within the meetings for discussion on specific activities to support the God for All themes; Tread Gently, Care Deeply, Follow Daily and Speak Boldly.

There are many people within the church who need great thanks for their support over the past year. Specifically during these times of a Covid pandemic, great thanks are given to Malcolm Lightfoot and team for the risk assessment for events at the Priory and adapting to an ever changing situation in relation to Covid. Lastly in thanks for support, the PCC have been very grateful to the congregation and wider community for the generous financial support to the Priory.

I would like to give my thanks to Jon Mellor, who stepped down as PCC secretary at the last APCM, for his time on the PCC but also for his support to me in the transition into the role as PCC secretary in May 2021. Phill Bearman stepped down from the PCC in October 2021 and, on behalf of the PCC, great thanks is given to Phill for his time on the PCC and in the role as Vice Chair. The PCC welcomed Revd. Richard Lee onto the PCC in February 2022. Great thanks is also wished on behalf of the PCC to Rosalie McAndrew and Wendy Mellor for all their commitment and counsel over the years as both are stepping down as Church Wardens at the APCM in April 2022.

Giving and Donations:

### Churchwarden's Social & Pastoral Report 2021

This report covers the period from April 2021 to March 2022 through another difficult and demanding year of Covid restrictions, but the PCC and congregation rose to the challenge and kept the Priory worship and administration in good order.

**Ministry** - From January to March the church was closed for public worship, but continued livestreamed services with recorded readings & prayers; meetings on Zoom; the magazine online. Thankfully worship resumed on Easter Sunday but no singing for the congregation. In September some normality returned, with 2 morning services; clubs and groups restarted in the church halls, and festivals were celebrated at Harvest & Christmas.

Many thanks go to the Ministry team who assisted with services, alternating with Becky for her Sundays at St Leonards. The Priory Christmas services were well-attended, although the worshipping congregation has halved in number over the year, with many viewing on Livestream from home.

**Youth Ministry** – Becky held All-age monthly meetings on Zoom for young people, and launched a new monthly 'Bible Story' service for young families. School services were cancelled. Members of the uniformed groups took part in the Remembrance Sunday parade and service; the Christingle was well-supported by children delighted to receive their candlelit orange and a takehome bag of goodies. Many returned for the Crib service; and to visit the Christmas Tree Festival and vote for their favourite. However few children attend church regularly despite the introduction of Storybags and activities in the Baptistery; and Youth Club has not attracted new members.

**Arts & Music & Social Functions** – Social events resumed at the Priory in the autumn – the Friends Organ Recital by Frank Bowler; a recording/filming concert by Harpists Northwest of Pachelbel's Canon; the Multi-Charities Christmas Fair with Art Exhibition & Sale; and the Friends Christmas Concert of Carols & Readings. Appreciative thanks go to the Priory Choir and Frank organist & choirmaster for uplifting church worship, and also the Advent & Christmas Carol services.

Many thanks to Deb Lee for organising the Mothers Union Garden Party & Traidcraft Fundraiser at her home in June; and leading a Priory Event in the Campaign against gender-based Violence, attended by Soroptimists, M.U. members, and WOW (Women Out West).

### **Initiatives**

**The Culture Recovery Fund** A PCC committee was set up to apply for a grant towards Priory projects and maintenance costs to support the re-opening of the church after the months of lockdown, reduced income and closure. The CRF bid resulted in a grant awarded of £8,600 which funded heritage projects – revised interpretive history panels in church and in the OCH courtyard – and payment of 3 months' utilities, some staffing costs, and 4 sanitiser pedestals. The Heritage Lottery Fund made these grants available to all heritage organisations with certain stringent conditions.

**The Priory Christmas Tree Festival** This was one of the original 900 Years Anniversary projects which survived the pandemic and was wonderfully celebrated thanks to the imagination of organiser Sarah George and the ingenuity of the 26 local organisations and individuals who took part. Over 300 votes were received and many visited during the 3 weeks, enjoying a most successful festival.

**Fundraising** – A good number of events took place and funds were raised for various charities.

Christian Aid Week raised £781 plus 25 Gift-Aid forms; Pop-In Café restarted in September resulting in £100 per week regularly; Harvest groceries were donated for the Foodbank and 25 Shoeboxes and bags of knitted goods for Romania. Christmas Greetings in the magazine raised £570 for Priory & the Children's Society; and the Christingle produced £248 also for the Society. Amazingly the Annual Multi-Charity Sale raised over £4,767 and Chris Robson's Art Exhibition/ Sale raised £500.

Finally the Christmas Tree festival totalled £337 shared between the Priory & St Bees RNLI.

Many thanks to everyone for their support and generosity in the past year.

**Tourism & Visitors** – The Priory has welcomed many more visitors this year - British holidaymakers unable to travel abroad and seeking the freedom of coasts and fells, or enjoying the facilities of holiday lets or the caravan & chalet park. The Priory publications have sold well, including Debbie Bowler's new notelets and postcards, and Donald Brownrigg's calendars. All very popular.

**The Priory Registers for 2021/22** recorded 10 baptisms, 6 weddings and 11 funerals. ### 2. Safer Recruitment, and Training

In 2021 our parish supported the following groups working with children and young people, and with adults who are vulnerable: Pop-In Thursday café and Bell ringing.

We are in the process of safely recruiting and training (largely by renewal of training) the leaders and volunteers working with the groups listed above in accordance with the Church's national guidance and we are ensuring that they will have received the level of training required by the Church. Our Safeguarding Officer will complete her training at the end of March 2022. We intend that our other leaders will be completing the new Leadership Safeguarding course by the end of May 2022. For most of them it will be a refresher course.

The past two years have been very different with regard to Church practices and activities because of the Covid 19 restrictions in place for much of the time. Safeguarding activity continued throughout. New Safeguarding guidelines and new training for all levels of personnel were issued by the Church of England and the Diocese in 2021. We are working to ensure that our leaders and other volunteers receive the new training appropriate to their role and have current DBS checks where required.

### 3. Church Policy and Guidance

Our Parish has adopted the House of Bishops 'Promoting a Safer Church; Safeguarding Policy statement', and Church of England safeguarding policy and guidance. The policy will be reviewed and renewed by the PCC in June 2022 and thereafter on an annual basis.

Hilary Hemm 12 March 2022 costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

The diocesan parish share is accounted for when paid. Any parish share unpaid at 31 December is not provided for in these accounts. Support costs, including governance costs, are those costs incurred directly in support of expenditure on the objects of the charity and include project management.

### 1.5. Tangible fixed assets and depreciation

Consecrated land and buildings and movable church furnishings Consecrated and beneficed property is excluded from the accounts by s.10 (2)(a) of the Charities Act 2011.

No value is placed on movable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal since the PCC considers this to be inalienable property. All expenditure incurred during the year on consecrated or benefice buildings and movable church furnishings, whether maintenance or improvement, is written off as expenditure in the Receipts and Payments Account and separately disclosed.

Other fixtures, fittings and office equipment

Equipment used within the church premises (if any) is depreciated on a straight line basis over 4 years.

Individual items of equipment with a purchase price of £1,000 or less are written off when the asset is acquired. Freehold land and buildings are depreciated on a straight line basis at 2% per annum.

### 1.6. Investments

Investments held as fixed assets are revalued at mid-market value at year ending 31st December.

Any purchases or sales of investments are shown separately within the Receipts and Payments Account. The gain or loss is shown in the notes to the accounts. 1.7. Current assets

Amounts owing to the PCC at 31 December in respect of fees, grants or other income are shown as debtors less provision for amounts that may prove uncollectable.

Short term deposits include cash held on deposit with the CBF Church of England Funds.

Notes to Financial Statements For the year ending 31 December 2021

### 1. Accounting policies

The principal accounting policies adopted, judgements and key sources of estimation uncertainty in the preparation of the financial statements are summarised below.

### 1.1. Basis of accounting

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis. The PCC constitutes a public benefit entity as defined by FRS 102. The presentational currency is UK Sterling £. The trustees consider that there are no material uncertainties about the charity's ability to continue as a going concern. In particular, consideration has been given to the recent COVID-19 pandemic in this assessment.

### 1.2. Fund accounting

General funds represent the funds of the PCC that are not subject to any restrictions regarding their use and are available for application on the general purposes of the PCC. Funds designated for a particular purpose by the PCC are also unrestricted. Restricted funds are those funds which must be spent on restricted purposes and details of the funds held and restrictions are provided in note 4.

Endowment funds, where the capital must be retained, are also explained in note 4

The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law. They do not include the financial statements of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

### 1.3. Income

All income is included in the Receipts and Payments Account when received. Care has been taken to ensure no income has been duplicated or omitted. Unrealised gains or losses are accounted for on revaluation of investments at 31 December. Whilst they are not shown within the Receipts and Payments account, details are shown in the notes to the accounts.

### 1.4. Expenditure

Expenditure is recognised on a payments. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates. Grants and donations are accounted for when paid over. Costs of raising funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes.

Expenditure on church activities comprises those costs incurred by the PCC in the delivery of its activities and services for its beneficiaries. It includes both

### Introduction

This report refers to the period 16/5/21 to 15/3/2022.

Questions, comments or further elaboration are invited by email or at the APCM.

### A) PRIORY

Due to the continuing adverse effects of Covid, certain work that would otherwise have been carried out since the last APCM has been limited.

Nevertheless, once again a great deal of effort by parishioners has gone towards maintaining our splendid but ancient Priory during the past year. Sincere thanks are offered for such support. (See section G)

As previously reported, nowadays our present voluntary manpower resources are increasingly insufficient to allow many scheduled maintenance items to be tackled and consequently more of the day-to-day work is having to be done by resorting to outside sources who require payment.

### Roof

In early June, our approved roofing contractors (Younghusband) attended to the leak in the Sanctuary roof above the north side altar rail.

In late November, damage was sustained to the roof by storm Arwen and was subsequently repaired by Younghusband (our preferred roofing contractor) at a total cost of £1,464 (inc. VAT).

This amount was subsequently reimbursed by our insurers (EIG), less the first £500 for which we are responsible.

### South Transept Roof Leak

The intended investigation into persistent roof rainwater leaks on the East and West walls of the South Transept and around the East end of the Nave was postponed in 2021 due to Covid.

Because it is suspected that such leakage may also be contributing to the troublesome internal high-level spalling in the chancel, no further work has yet been done on this.

Discussion is currently being held with Brendan Teasdale (masonry and roofing specialist recommended by our architect Chloe Granger) about conducting a detailed investigation into the cause of the leakage and suggesting remedial action. The intention is that if the problem can't be resolved at the same time as the investigation, (for instance if grant funding is needed) then the condition left at the conclusion should be no worse than at the start.

### **Heating**

In October, a registered gas engineer from Roland Hill Ltd (who were responsible for installing the original gas supply into the premises) conducted a complete check and maintenance of the entire gas installation and certified that this is operating safely and satisfactorily.

The recommendation that the gas pipework in the under-croft should be painted in the official identification colour, which would also prevent corrosion, has since been implemented.

### **Electrical Matters**

Over the course of the year, our approved electrical contractor (SEL) has replaced two exterior lights in the vicinity of the bell tower access door and a further two on the gateposts by the church entrance.

Storm Arwen caused damage to two external lights resulting in an intermittent fault due to dampness causing the circuit breaker to trip and take out other critical lights. This has subsequently been rectified but the fitting on the NE corner of the building still requires replacing.

### Chancel Floor

Until such time as the rainwater leaks have been rectified and affordable funding is available, progress is in abeyance regarding improvements to the Chancel stone flags & tiles and providing a new oak covering over the heating pipes.

### Pews

All the pews which were temporarily repositioned as a precautionary measure against Covid have recently been returned to their original places.

### Organ

Servicing has been satisfactorily carried out during the year.

### Security

The alarm system was serviced during the year under the contract with Compass

### **Gutter clearing**

Low level gutters and downspouts on the Priory were cleared in late Autumn and early 2022 thanks to Malcolm Lightfoot and Jack Hale supplemented by James Skelton and Unblock Cumbria.

### Cleaning

Frank and Debbie Bowler have continued to painstakingly look after the Priory and both halls for which we are most grateful. Covid precautionary measures have caused a considerable increase in their workload.

### Contactless giving

Since being permanently installed last summer (2021), the new contactless giving

device, allocated to us as a participant of Carlisle Diocese pilot scheme, has provided visitors and churchgoers with the opportunity to make card payments to the Priory by digital means as an alternative to cash donations. This is very simple to use and is proving effective.

Arrangements are also presently in hand to install an additional portable contactless-giving device in the Lady Chapel in a semi-permanent manner which would allow it to be temporarily relocated elsewhere for special occasions.

### **Priory Embroidery Team**

This dedicated group have continued working, subject to social distancing, on a commemorative banner as part of the 900 years celebrations. Thanks to all concerned for their hard work. An appropriate display stand is to be provided by Alan Armstrong.

### **Priory Flower Arrangers**

Thanks are due to all those who have who have agreed to take on monthly duties, following Mary Branford's retirement, and also to those who generously contribute to the flower fund. All efforts continue to be greatly appreciated.

### **B) COLLEGE HALLS**

### Old College Hall

Recently the troublesome external door handle/lock has been replaced, and also minor leaks from the fan assisted radiators have been rectified by Roland Hill and Malcolm Lightfoot.

Currently high-level downspouts at the NE end of the building are in need of clearing.

### New College Hall

Tiles blown off/loosened during the storm in late November have been subsequently repaired by Younghusband.

All fluorescent tubes in the lower room were replaced in November.

Arrangements for long-term exclusive rental of the upper room for Sankaikuni Judo have recently been completed and the room is now occupied. A combination lock was fitted to the upstairs door and the room suitably cleared by R. McAndrew and others.

### C) CHURCH GROUNDS

### Interment of Ashes

Because space is no longer available in the lower section of the Lychgate cremation area, the previously unused upper area has been brought into use this year and a detailed layout plan prepared to ensure correct alignment of the

initial slabs which will set the pattern for the rest of the area.

### 2. Headstones

A survey of all memorial stones (i.e. checking on stability) was carried out in December 2021 by I. McAndrew, J. Haile, M. Lightfoot, D. Hope. Some 27 stones were identified as possibly requiring attention. Following that initial survey, Mark Hodgson from Cumbria Headstones (who has previously undertaken remedial work in the graveyard) was consulted at our request and recommended that a total of 22 should receive attention. The estimated cost of remedial work per stone ranges between £50 & £250 depending on the size and whether it would be buried to the level of lowest inscription or fully re-set.

To date, cautionary notices (as approved by EIG) have been posted warning that some gravestones/memorials may be unstable. In addition, hazard tapes with warning notices have been temporarily placed on several headstones considered to be potentially unsafe.

Arrangements are currently being made to prepare a list of living relatives to be contacted via a suitable letter from Becky. At the same time, a review with Cumbria Headstones is to determine priorities, appropriate actions and timing before proceeding any further.

### **Trees**

Work on the cherry trees beside the lychgate path was undertaken after flowering in 2021 by

our approved contractor (KP Arborists) who also paid close attention to the poplar trees in the vicinity of Holly Mews and carried out light pruning as appropriate.

(Note - Because in the past, the Copeland consultant rejected an application for crown reduction etc, only light pruning is permissible within this area. Concerned local residents have been made aware of the situation.)

In late Autumn, the overgrown Portuguese Laurel bush in the North graveyard, which was proving troublesome for grass cutting, was suitably cut back to a low level.

### Clearing OCH courtyard

As one of the projects for which money was made available from the Cultural Recovery Fund, and with the approval of the Archdeacon, this unsightly area has been cleared. Historic stones have been re-arranged against East wall and gravel spread. An explanatory notice board has been installed on the nearby wall and the site of St Bees Man delineated by inlaid markers.

Thanks are particularly due to Chris Robson and Colin Wadey.

### **Railings**

The iron railings between the main entrance and the first bush on the Priory drive were successfully refurbished last summer (by Miami Lights). It is intended to continue work further beyond this in 2022

### **Future plans**

This year has seen the introduction to the Priory of 'digital giving', principally via a contactless giving device located in the Priory and also via the Priory Web site, our aim is to further promote digital giving routes to generate income. Increasing income by; additional hiring of the Priory and the New and Old Collage halls, considering broader commercial activities and, continuing to support the stewardship campaign are all themes for the near and medium term future.

Work to maintain in good order the fabric of the Priory, associated buildings and grounds deferred from recent years still needs completed. Of particular note is addressing rainwater ingress to the South Transept for which a cost in the region of £15,000 is anticipated for 2022.

### Statement of members' responsibilities

I report on the accounts of the Parochial Church Council of St Bees Priory for the year ended 31 December 2021 set out on pages (12 to 20 in original doc.)

### Gates

Following the disappearance of the combination lock on the West gate of the graveyard, a replacement lock has recently been fitted and details circulated as appropriate and also recorded in the Vestry key press.

The dilapidated condition of the gate into churchyard from Priory paddock has recently been brought to the attention of the B&W committee.

Grass cutting

Annual servicing has been carried out on the grass cutting equipment by Lloyds at Carlisle.

Work by the enthusiastic grass cutting team carried on until late Autumn, in full compliance with Covid 19 issues.

### Other maintenance work

During the year, work carried out by James Skelton includes clearing of medieval drain, low level gutters, ground drain covers, various downpipes, leaves from paths and areas, weeds from various overgrown paths, replacement of rotted edging on West gate path, repairs to sections of graveyard wall, etc. All appropriate debris was taken to compost.

In addition, we owe thanks to all the dedicated volunteers, and partners, who have continued to ensure that our church grounds are kept in good order - it's a demanding task but much appreciated by visitors and locals alike.

### E) HEALTH & SAFETY

### **Policy**

We have continued to take all reasonable measures to ensure compliance with St. Bees PCC Health & Safety Policy.

### Care & maintenance arrangements during restricted access due to Covid

Special attention has been given to ensure strict adherence to up to date Government guidance

and the latest versions of the Church of England guidance documents.

Special thanks are due to Malcolm Lightfoot for carrying out risk assessments for church and halls - an essential and ongoing task which he has painstakingly fulfilled.

### Safety Inspections

The following Fire Risk Assessments were carried out in August: Church & Vestry, NCH, OCH & Bell Tower Portable Appliance Tests (PAT)

Various electrical devices in common use have recently been tested and appropriately recorded. Thanks to IMcA & R.McA.

Those living near to the Priory are encouraged to keep an eye on the property and inform Becky or a Church Warden of any suspicious activity.

### F) Other Matters

### 2022 Quinquennial inspection

The timing of this essential inspection has yet to be finalised with our Architect.

### **Priory Spaces Meeting**

In early November 2021, a meeting was held to consider how the Priory and halls might be made more welcoming whilst the Priory remained primarily a place of worship. This was attended by Chloe Granger, Becky, ICR, WM & JRK. A summary of the suggestions with estimated cost is awaited.

### **SWOT Analysis**

A team comprising T. Kelly (leader), G. Gilmour, M. Lightfoot, J. Kennedy have recently conducted a detailed SWOT analysis which has been warmly welcomed by the PCC. This is currently being actively progressed

### Live streaming from the Priory

This continues to be in successful operation and a second camera is under consideration. There is still an urgent need for further volunteers to assist in setting up and operating the system. (Hands-on familiarisation and a simple step guide are readily available.)

### External P.A. Equipment

In order that either of the two devices in our possession can be made serviceable for future outdoor use, a suitable dynamic microphone has been purchased at a cost of around £80.

### **Financial review**

The PCC's total funds at 31 December 2021 were approximately £27,600 (including liabilities) higher than at the start of the financial year (2020: increase of approx. £11,178).

The surplus for 2021 reflects the £20,000 growth in value of the invested funds (2020: gain £9,000) while also charging £10,100 depreciation on the New College Hall.

The PCC remains in a satisfactory position with free reserves being sufficient to cover four months' recurring expenditure even should all income streams fail. This buffer is in line with the position at the beginning of the year, which was four months' worth of recurring expenditure.

This year has again been a year in which actual spends were less than predicted when setting the 2021 budget. Availability of suitable contractors to undertake the Building and Works planned schedule of work to the Priory and grounds together with reduced cost for a Parish administrator being the principal contributors.

### Reserves policy

The PCC does not currently have a reserves policy.

### **Principal funding sources**

Aside from the income generated by church hall lettings and other activities for generating funds, the principal funding continues to be voluntary income through planned giving £46,935, service collections £3,170, gift aid on donations £13,770 and general donations £8,800, which together represents 70% of incoming resources; additionally, three grants totalling £13,138 supplemented 2021 income increasing the overall percentage of income to 82% from these sources.

### Risk management

The members have examined the major strategic, business and operational risks which the PCC faces and confirm that systems have been established to enable regular reports to be produced so that the necessary steps can be taken to lessen these risks.

### **EMBROIDERY GROUP**

The decision to embroider "something" to mark the 900 year celebration of worship in the Priory was taken in June 2019, when we were given the all clear from the Archdeacon on a mock-up of ideas put before the P.C.C. Never did I think that almost 3 years later we would still be stitching. I hesitate to predict a finishing date, we live in such uncertain times - but one thing is certain - there will be a celebration when the last stitch is sewn.

Our numbers have fallen somewhat so whilst progress is slower, the work continues to grow, it has proved to be a challenge in size and complexity, but we are certain it will prove worthy of display in the Priory to commerate such a momentous occasion .
